SUBJECT: Request ECU Board of Trustees Approval to Lease ± 4,520 SF of Office/Clinical Space at 108 Fire Tower Road

ECU Physicians, Department of Pediatrics requests ECU Board of Trustees approval to Lease by Acquisition \pm 4,520 SF of office/clinical space located at 108 Fire Tower Road, Suites A, B, and C from Wainright Holdings, LLC.

This lease is deemed strategic in nature as ECU Pediatrics Family Autism Center has been in this location since December 2012. The space is adjacent to the Greenville TEACCH Center that serves individuals with Autism Spectrum Disorders and its proximity provides collaborative opportunities and helps leverage assets to help families in our region to access autism resources from a familiar and centralized location.

The lease term will begin October 1, 2019 for at term of three (3) years with three (3), one-year renewal options. The lease rate will be \$49,800 per year (\$11.02/SF/YR). ECUP will pay for janitorial and utilities.

The lease has been approved by the ECU Physicians Property Review Committee and the Dean, Brody School of Medicine.







Parking Update

Board of Trustees September 2019



Revenues

- Must be self-supporting and receives no state funding
- Must transfer 80% of fine revenues to the State Department of Public Instruction
 - State allows us to keep 20% to cover costs to collect fine revenues
- Revenue is realized from permit sales, hourly guest, visitor, and event parking



Inventory

- University has 12,605 parking spaces, including permit, ADA, reserved, service, visitor, and patient parking spaces
- 9,983 available permit parking spaces for 28,000 faculty, staff, and students
- Remainder of spaces are for specialized parking needs such as service/maintenance vehicles, patients, and hourly visitor/guest parking



Parking Zones, Permits, Hourly Parking

- Parking is by a Zone System (A, B, C, D, and Garage)
- Zone prices are based on convenience and access
- Permits available for faculty/staff, resident students, and commuter students
- Permits range in price from \$140 to \$720 per year
- Cost for hourly guest and visitor parking is \$1.00 per hour or \$5.00 per event


